A 2022 JCCF grant helped God's Hands At Work serve 300 families through its mobile food pantry. Contributing to its efforts were community members who volunteered to package food boxes, including individuals from two nonprofit organizations, church groups and students from the local middle and high schools.

2023 GRANTS

In partnership with the Foundation for Appalachian Ohio, the Jackson County Community Foundation awarded nine grants, totaling \$18,050, in 2023.

CITY OF JACKSON


Jackson's Hillcrest Park features a swimming pool, basketball/pickleball court, skatepark, shelter houses – and soon playground equipment that will provide recreational opportunities for younger children. This grant is helping fund playground installation, adding to the health and wellness benefits the park provides and fulfilling a community dream.

GOD'S HANDS AT WORK

God's Hands At Work started its Jackson County mobile food pantry three years ago to help address food insecurity in the county's most rural areas. At quarterly distributions throughout the county, they provide 300-400 individuals with a box containing enough food for approximately two weeks. This grant funds the purchase of food for those distributions.

GRACE CLINICS OF OHIO INC.

Jackson County Grace Clinic is a free medical ministry that provides uninsured and underinsured community members with free medical appointments, prescription assistance and specialist appointments. This grant is helping to fund the clinic's pharmacy vouchers and operational expenses, providing increased access to medical care.



Residents of Jackson County have expressed a desire for additional playground equipment at Hillcrest Park – a project that received funding through a 2023 JCCF grant.

2023 GRANTS

JACKSON COUNTY 4-H ADVISORY COUNCIL

With support from a JCCF grant, the 2023 Jackson County Spring Project Fair and 4-H Open House resulted in 52 additional 4-H members and 71 more adult volunteers. This grant is supporting the purchase of curriculum and supplies for the 2024 event – an investment in our youth and in 4-H, which teaches life skills and encourages our young people to be engaged, active and healthy community members.

MAKE WELLSTON BEAUTIFUL INC.

The Ohio Hill Country (OHillCo) Festival observed its 50th anniversary in 2023, a milestone moment for this celebration of Wellston's rich Appalachian heritage. This grant is purchasing materials for new quilt racks and art display boards for the festival's Art Show and Quilt, Needlework and Craft Show. These items will be built by Wellson OHillCo Society members and volunteers from Make Wellston Beautiful and Wellston Rotary.

OAK HILL AREA CHAMBER OF COMMERCE

The Oak Hill Area Chamber of Commerce is commemorating the village's 150th anniversary – and making history – by commissioning "The World's Largest Acorn" sculpture at Central Memorial Park. This grant is contributing to the fabrication and installation of the sculpture, which will serve as a permanent reminder of Oak Hill's sesquicentennial and attract visitors to the community.

SOJOURNERS CARE NETWORK

Youth experiencing homelessness face significant hurdles throughout the year, but the holiday season can be especially difficult. This grant will provide Jackson County youth experiencing homelessness a warm holiday experience, offering them a respite from their daily hardships in a nurturing environment where they can feel a sense of community, support and the simple joys of the season.



HONORING AND REMEMBERING SANDY BORDEN

The Jackson County Community Foundation lovingly dedicates its 2023 Annual Report to Sandra "Sandy" Leigh Borden, who passed away on Sept. 10, 2023, and whose legacy of service to Jackson County includes serving on JCCF's committee.

During her time as a JCCF leader, Sandy gave as she did in so many ways in our communities – with the heart of a servant and a commitment to uplifting opportunities for all who call Jackson County home. She was a child of Appalachia whose love and dedication to serving others embodied her career and her community involvement.

The footprint Sandy left in Jackson County and in JCCF's journey will continue to guide our path for many years to come.



INVESTING IN JACKSON COUNTY'S YOUNG LEADERS

In 2023, FAO partnered with its affiliate foundations to support projects developed and implemented by local youth under age 18. The goal of this funding is to empower young leaders and inspire them to embrace greater roles in their communities.

JCCF awarded youth-led project grant funding to two Jackson County nonprofits, established by local high school students to assist their peers and families in our communities.

KICKS 4 COATS

This grant is supporting
Kicks 4 Coats, a nonprofit
founded by Jackson
High School senior Ethan
Crabtree that provides
warm coats to Jackson
County children ages 1-18.



"A lot of parents in the community and just even around the world today are struggling. It's a hard world to live in, especially now," says Ethan. "I figured the best way I could help was just getting the stuff that at least would help keep them warm."

Ethan, who also involved his football teammates in his work, raised enough money to distribute 124 coats in 2022. His goal for 2023 was 150 coats, but with the grant from JCCF, Ethan gave away more than 300 coats last year. The coats are being provided to all schools in Jackson, Oak Hill and Wellston, as well as to the Jackson Area Festivals & Event's Christmas program.

INVESTING IN JACKSON COUNTY'S YOUNG LEADERS

SOUTHERN OHIO SOLES INC.

This grant is supporting Southern Ohio Soles Inc., a nonprofit established by local high school students Isaac Slark, Dayne Neff and Max Gentry. Their mission? Ensure that every student in Jackson County has an adequate pair of footwear, empowering local youth to take a step toward a brighter future.

"Growing up, I always noticed the differences in the classroom," says Isaac, a Jackson High School senior. "Some kids didn't have a winter coat; kids didn't have a lunch. ... This past summer, I came together with my friends, and we decided that we wanted to make a big difference in our community."



In the first semester of the 2023-24 school year, the nonprofit gifted 89 pairs of shoes to students in need in Jackson County's public schools. The JCCF grant will fund nearly 100 additional pairs of shoes.


