### 2024 Grants

The Monroe County Community Foundation, in partnership with the Foundation for Appalachian Ohio, awarded seven grants, totaling \$24,590, in 2024.

### Beallsville Volunteer and Community Fire Department

When emergency responders from the Beallsville Volunteer and Community Fire Department respond to structure fires and vehicle accidents involving power lines, they lose critical time waiting for staff from the power company to arrive and cut power to any live wires. This grant is funding equipment that will allow firefighters to safely check for electrical currents on power lines.


### Lewisville Community Center

The Lewisville Community Center often serves as the heart for events in the village, hosting everything from holiday celebrations to more than 100 private gatherings each year. This grant, supported by the Baker Education and Economic Development Fund, is helping to replace the center's broken sound system.

### **Monroe County EMA**

Two grants were awarded to the Monroe County Emergency Management Agency:

- To provide house number signs for Monroe County homes to help guide emergency responders
- To support disaster recovery efforts following the April 2024 storms and tornado



**Community highlight** 

Four River High School students contributed to a 2024 project at their former elementary school, which now serves as the Sardis Community Center. They put the finishing touches on a project to restore the terrazzo tile floor of the center's kitchen, helping to place the appliances back in the facility that hosts everything from community gatherings to family reunions. The project received funding from a 2023 grant from MCCF.

### A milestone and momentous year for MCCF

2024 was a milestone year for the Monroe County Community Foundation, as we celebrated our 10<sup>th</sup> anniversary of bringing together gifts of time, talent and treasure to make a lasting difference in our communities.

It was also a momentous year. In early 2024, FAO announced a 50-cent match for every \$1 given to any endowment fund within affiliate foundations' family of funds. A total of \$300,000 in match funding was available for each affiliate foundation through Nov. 8. Thanks to the generosity of our community, MCCF met our match! Combined with another match opportunity FAO made available at the end of 2023, we raised more than \$1.1 million in donations and matching funds to support a flourishing Monroe County for generations to come.

### 2024 Grants

### **River Elementary School PTO**

Students' enjoyment of the River Elementary School playground is often disrupted when the balls they play with bounce over the fence. This grant is helping to replace the existing fence with a taller one that will serve students and all who use the playground outside of school hours.

### **Tri-County Help Center**

In 2024, an MCCF grant allowed Tri-County Help Center to create Safe Spaces, a support group where Monroe County youth can share concerns and goals while engaging with their peers. This grant is helping to fund the continuation of the program in 2025 – and filling a need expressed by local families.

### **Woodsfield Kiwanis Club**

The Woodsfield Kiwanis Club celebrated 100 years of service to Woodsfield and surrounding communities in 2024. This grant is supporting the club's Coats for Kids project, which for 20+ years has provided winter clothing to K-8 students in the Switzerland of Ohio Local School District who qualify for free or reduced lunches.



In September 2024, community members and groups came together for the Coats for Kids BBQ to support the Woodsfield Kiwanis Club's annual program that provides winter clothing to hundreds of K-8 students in the Switzerland of Ohio Local School District. The project has received grant funding from MCCF for the past four years.

## Since our founding in 2014, MCCF has awarded more than \$96,000 in grant funding.



### Answering the call to lead and serve in Monroe County

In 2023, FAO and its affiliate foundation partners welcomed the inaugural class of Growing Home Fellows, including Andrea Blackstone, Lauren Craig, Elizabeth Hoover, Mattie Vinskovich and Rusty Winland, who live and/or work in Monroe County. In exchange for committing to live, work and volunteer in their communities for five years, these young community builders receive a financial stipend and participate in a leadership program that includes coaching. In 2024, the fellows began implementing service projects in our communities. Two of those projects include:



### **Mattie Vinskovich**

Mattie Vinskovich of Woodsfield is a media arts teacher and advisor to the Business Professionals of America and yearbook staff at Monroe Central High School. Mattie is serving on the Monroe County Mental Health and Recovery Board for her Growing Home Fellowship service.



#### **Rusty Winland**

A fourth-grade math teacher at Caldwell Exempted Village Schools, Rusty Winland is serving the Beallsville Volunteer Fire Department. Rusty secured grant funding through the Monroe County Community Foundation to purchase equipment that will allow firefighters to safely check for electrical currents on power lines. He also participated in FAO's inaugural Growing Home Fellowship pitch competition and secured funding to purchase an automated external defibrillator and Ambu bags to assist with emergency cardiac arrest calls.

### Honoring a family's legacy of giving | In memory of John Baker August 8, 1931 - March 4, 2025

The Foundation for Appalachian Ohio created the Chaddock Philanthropist of the Year Award in 2016 to honor Jeff Chaddock and Mark Morrow for their visionary planned gift to support the region and its nonprofit organizations. The award celebrates those who have made an outsized difference in Appalachian Ohio through their charitable giving.

In 2024, the Baker family of Monroe County received the award in recognition of a legacy of giving that spans generations – from John Baker, who passed away in March 2025, and his late wife, Lois, to their children, grandchildren and great-grandchildren.

The family's service to community dates back nearly seven decades to when John started the family business with one piece of farm rental equipment. As the business grew, so did the Bakers' commitment to helping others. When John's son, Greg, died unexpectedly in 2011 during his service as a volunteer firefighter, the Bakers' desire to honor family legacies



and to support the community they call home grew even stronger.

Over the years, the Baker family has established or championed nine separate endowment funds within MCCF's family of funds, covering everything from economic development to heart health awareness and much more.
