

Bridging Our Opportunity Gap


Talent. Dedication. Inspiration.

They are plentiful in our nonprofits, schools, and communities where citizens are striving to create a region abundant with opportunities. Yet, as we listen to these leaders, we find one barrier holds back every effort to advance their missions and make a lasting difference. It's our region's philanthropy gap.

If we look at our philanthropic assets, we find our citizens access a mere \$693 in per capita philanthropic support while Ohioans outside our region receive \$6,348. **While the region's challenges are complex, interwoven, and generational, we can rise to this challenge of closing the philanthropy gap.**

Closing the philanthropy gap will empower our region's leaders in education, arts and culture, health and human services, community and economic development, and environmental stewardship to create opportunities for the region's citizens.

Through philanthropy, not only can we provide the resources these leaders need, we can provide the child of Appalachia in this graph every opportunity necessary for success.

A New Story Begins Now.

The philanthropy gap data confirms what we already know – to make lasting change, we need to grow funding to create opportunities in our region.

Our region's challenges are complex and interwoven. It is hard for our *Educational* investments to succeed if the children we're helping come to school too hungry to learn.

That means *Health & Human Service* investments are needed, as well as *Community & Economic Development* investments, to ensure the children's parents have good jobs and can provide for their families.

And we all know how vital it is for our communities to be safe, healthy, and vibrant, which requires support for *Environmental Stewardship* and *Arts & Culture*.

Simply put, we cannot invest in one area alone and achieve the transformations our region has long awaited. This is why FAO has chosen to develop five areas of funding simultaneously, areas we call the *Pillars of Prosperity*.

Every investment into one *Pillar* will reinforce and strengthen investments in the others.

"I see the *Pillars of Prosperity* as an orchestra," said Mick McLaughlin, FAO Board Member Emeritus. "Each *Pillar* can play a beautiful solo, but it's only when they join together that we hear a symphony."

Grantee Spotlight: From Cradle to Career

It doesn't take long to realize a high school diploma alone doesn't carry graduates as far as it used to. By the end of this decade, it is estimated two in three jobs will require at least a two-year degree from a post-secondary school. Schools know they alone cannot prepare students for their next steps. It takes a community working together.

With a grant from FAO this year, local leaders within our region launched the Appalachian Ohio P-20 Council, a way for educators, business, government, philanthropy, and community to work together to support students pursuing the education they need.

P-20 councils are collaborations between these various sectors to create an educational system where students are nurtured from their earliest days, so that each educational transition is seamless, from pre-school up through college or career preparation.

Having a P-20 Council in Appalachian Ohio that serves a nine-county region is brand new. FAO's grant has helped these communities begin a new way of increasing our region's educational attainment, supporting student success, and encouraging the future leaders of our communities.

Creating a new kind of community partnership like this meant approaching education across all ages and thinking about how students transition into the workplace. As Maureen Boggs, Early Care & Education Division Director for the Corporation for Ohio Appalachian Development said, "Acknowledging that early childhood is part of the spectrum opens the door to what's going to come for the future."

And P-20s are all about the future, both those of the students and of the communities where they are growing up. "It's a lifelong process," said David Branch, superintendent of the MVESC. "Educational pathways lead students to careers that will allow the community to thrive." Beginning with our youngest citizens, the P-20 has its eyes on supporting the future leaders of our communities.



PARTNERS

In partnership with the Muskingum Valley Educational Service Center (MVESC) and the Ohio Valley Education Service Center, the P-20 Council serves Coshocton, Guernsey, Hocking, Morgan, Monroe, Muskingum, Noble, Perry, and Washington counties and plans to expand in the future.

Growing Home

For so many of us, what's closest to our hearts is our home. It's the people and places who mean the most to us. It might be where we live now or it might be where we grew up, but it's our community.

FAO partners with donors and communities across our region to help address unique local needs through the growth of funds.

Our work to *Grow Home* is built upon one of the very reasons FAO was founded in 1998 – **to make sure every county in Appalachian Ohio is supported by a strong local community foundation.** We are climbing closer to seeing this goal become a reality. Now, with the establishment of the Monroe County Community Foundation Fund this year, we have partnered with nine counties to inspire local philanthropy.

Local Funding Spotlight: A \$1 Million Goal in Southern Perry County

The **Southern Perry County Academic Endowment Fund** (SPCAEF) has always looked to the future. With a mix of scholarship and community grantmaking funds, they have been supporting students and southern Perry County since 1987. That's when academic leaders came together to turn a \$5,000 donation into a substantial resource for students and residents of southern Perry.

“We are getting staff services as opposed to volunteers, so now there are people dealing with marketing and follow-up with donors, which was hard to do with a volunteer board,” said SPCAEF committee member John Winnenberg. “I think not only are we going to see a better return on investment but also more people showing interest in donations over time.”

A part of the **Community Foundation for Perry County Family of Funds**, the SPCAEF is a vital resource for Perry County, which has an abundance of intelligent students who often lack the resources to further their education.

Having grown to over \$954,000, the SPCAEF now has a \$1 million goal in its sights.

With the generosity of high school alumni and members of the community, the resources grew to over \$867,000. Invested in certificates of deposit (CDs), the Fund provided generous scholarships and grants until fluctuations in the economy showed the fragility of the CDs as a long-term approach.

This was when the SPCAEF reached out to the Foundation for Appalachian Ohio to help grow the Fund as a permanent resource for students, summer programs, cultural efforts like the Little Cities of Black Diamonds, and more.

Grant Spotlight: Visionaries in Harrison County Protect Sight for Future Generations

As a former junior high and high school teacher, coach, and principal, Bob Burdge has seen the difference a vision screening can make. He vividly remembers one student who was having persistent headaches. It wasn't until a school nurse suggested an eye exam that the student got glasses. As Mr. Burdge said himself, "Everything turned around for him."

The members of the Cadiz Lions Club in Harrison County, like Mr. Burdge, have always been dedicated to eyesight conservation as part of its mission of community service. Committed volunteers have been helping identify children in Harrison Hills City Schools with vision challenges for years, but were doing so with nothing more than an eye chart. It is crucial for vision problems to be detected early, yet the Lions Club did not have the necessary resources.

The Gulfport Energy Fund, the Foundation for Appalachian Ohio, and the Harrison County Community Foundation Fund awarded a grant this year to the Cadiz Lions Club to

change that. The grant funding was used to purchase a Welch-Allen Spot Vision screening kit with accessories. This highly sensitive piece of equipment is able to detect vision problems in students quickly with remarkable accuracy, providing schools with a comprehensive way to test all students and ensure those children who need assistance will have it.

The Lions Club has already screened 200 children this year, including all of Harrison's pre-school and kindergarten students, with 40 students receiving referrals for full eye exams.

With their new equipment up and running, the Cadiz Lions are ready to offer assistance beyond the Harrison Hills City Schools to other Harrison County school districts as well as in neighboring Belmont, Guernsey, Jefferson, and Monroe county schools. The Cadiz Lions have hundreds of screenings lined up this year, giving them hundreds of opportunities to turn everything around for a child.

106 Shares of FAO Sold!

We're making history here at the Foundation. This year, we created a first-of-its-kind campaign for community foundations. Modeled after private sector businesses going public by selling shares of stock to investors, our **Leadership 100** campaign broke out of the traditional fundraising mold.

From the beginning, the Foundation for Appalachian Ohio has let the needs of our region, and not the conventions of traditional fundraising, drive our decisions and activities. So this year, our IPO – Initial Philanthropic Offering – sought 100 “shares” of the working capital needed for FAO to work with communities, nonprofits, and schools to grow the funds needed to support their work forever.

On November 13, we rang the opening bell on a new era of philanthropy for Appalachian Ohio. We celebrated the generosity of more than 75 individuals, businesses, and organizations who became shareholders. **Their 106 shares raised more than \$3.4 million, surpassing our original goal.**

Shares of FAO weren't really sold, of course. Each \$32,000 share was a gift from a donor who believed in our mission to create opportunities and is committed to the vision of \$100 million in philanthropic resources to support Appalachian Ohio's citizens.
