Since 2009, we've been serving the people and communities of Monroe County. We are filled with gratitude for all we have achieved together and with optimism about the opportunities that lie ahead.

The foundation was created to help and inspire residents and those who love Monroe County give locally. In 2022, our community fund helped donors "double their impact" and grow grant money available for the future. As a local affiliate of the Foundation for Appalachian Ohio (FAO), we received a dollar-for-dollar match for the more than \$171,000 donated to the Monroe County Community Foundation.

In fall 2022, we provided eight grants totaling nearly \$15,000 to advance projects and programs throughout the county and hosted a September community gathering and fund update at the historic Monroe Theatre.

This report spotlights only a few of the many ways we are making a difference in Monroe County. None of this would be possible without you. Our donors and supporters are at the heart of everything we're able to provide for our residents and communities today and for generations.

### **MAKING A DIFFERENCE**

With the support of our donors, we award grants to nonprofit and public organizations for projects and programs that benefit Monroe County, focusing on five areas essential to creating transformative and sustainable change: arts and culture, community and economic development, education, environmental stewardship, and health and human services.

#### SUPPORTING A COMMUNITY EFFORT

Broken Timber Outdoor Education Center was founded as a place to encourage youth and their families to enjoy the outdoors and wildlife. Despite steady growth of its programming, it lacked a space to hold outdoor classes.

That all changed last year after the Monroe County Community Foundation, through the Baker Education and Economic Development Fund, awarded the center a grant to construct a pavilion and purchase audio equipment. Area residents volunteered to help clear the land, and students in the Swiss Hills Career Center's construction program completed the build while honing their skills.

The pavilion will host its first programming this spring, welcoming 4-H clubs, Boy and Girl Scouts, students, and senior citizens to learn about wildlife habitat, conservation, and outdoor activities. A 2022 grant from the Monroe County Community Foundation will help fund a concrete floor for the pavilion.







#### **ENHANCING COMMUNITY RESOURCES**

The Monroe County Community Foundation invests donors' dollars into projects and programs that elevate the quality of life in communities throughout the county.

In late 2021, the Lewisville Community Volunteer Fire Department was wrapping up construction on a new firehouse, built to also serve as an emergency shelter for the community. With the structure in place, the department needed funding to equip it with some of the basic accommodations of a gathering space.

# OUR IMPACT IN 2022

#### FALL 2022 GRANT RECIPIENTS

The Monroe County Community Foundation, in partnership with the Foundation for Appalachian Ohio, created nearly \$15,000 in opportunities across our communities through grants to the following organizations:

#### ENHANCING COMMUNITY RESOURCES (CONTINUED)

With a grant from the foundation, the department was able to purchase tables and chairs, used to host many community events, including the department's biggest Basket Bingo Fundraiser to date and several funeral dinners for local families – and ready should the facility be needed as an emergency shelter.

At the nearby Lewisville Community Center, volunteers lead a monthly Story Hour for area children ages 1-5, reading them a story and then providing them an activity. With a 2021 grant from the foundation, the center purchased child-size tables and chairs as well as toys, art supplies, and learning materials for the year-round program. In 2022, approximately 75 children and their parents or guardians participated in this free program that brings children together to learn and play.
