With the support of our donors, we award grants annually to nonprofit and public organizations for projects and programs that advance opportunities across areas of need, known as our Pillars of Prosperity.












Our investments improve health, create educational opportunities, advance economic development and environmental stewardship, and provide access to arts and cultural experiences.



OUR GROWING HOME FELLOWS

In 2023, FAO and its affiliate foundations welcomed the inaugural class of Growing Home Fellows, including seven individuals living and/or working in Guernsey County: Zack Canter, Kirstin Carpenter, Nicole Earley, Luke Fabian, Layne Neuhart, Brittany Nixon and Emily Regan.

The Growing Home Fellowship is designed to recruit, retain and nurture our region's next generation of community builders. In exchange for committing to live, work and volunteer in their communities for five years, the fellows receive a financial stipend and access to a leadership program.



2023 GRANTS

In partnership with the Foundation for Appalachian Ohio, the Guernsey County Foundation awarded 17 grants, totaling \$46,372, in 2023.

CAMBRIDGE AREA YMCA

The local YMCA serves as a resource for individuals and families looking to stay active and engaged in their community. This grant is funding equipment for the organization's gymnastics team, weekly gymnastics classes and those attending events at the YMCA – helping our community tumble toward success and contributing to an advanced training facility.

CAMBRIDGE INTERMEDIATE SCHOOL (2 GRANTS)

Two grants are helping to fund incentives for high achievement and positive behavior at Cambridge Intermediate School. One grant is supporting a school visit from the Columbus Zoo and animal ambassadors for an end-of-year celebration. The other is helping to stock the school's PAX store, providing students with tangible rewards and incentives for exhibiting positive behaviors and promoting important social and emotional skills.

CHILDREN'S ADVOCACY CENTER OF GUERNSEY COUNTY

According to the U.S. Centers for Disease Control and Prevention, one in four girls and one in six boys will experience sexual abuse before reaching the age of 18. This grant is helping to fund a new program that will offer comprehensive child sexual abuse prevention training to adults in Guernsey County.

DICKENS VICTORIAN VILLAGE

Known as the "Most Unique Holiday Destination in the Midwest," Dickens Victorian Village showcases Guernsey County to visitors from near and far. This grant is funding a sound system for events, which will enhance the Trolley Tours, Cemetery Tours, Victorian Teas, school field trips and public gatherings hosted by the organization.





A 2022 Guernsey County Foundation grant allowed Cambridge Intermediate School to launch an afterschool STEM Club, providing students more exposure to the STEM curriculum and hands-on, real-world experiences – from designing and modeling school spirit window clings to engaging in robotics.

EAST CENTRAL OHIO EDUCATIONAL SERVICE CENTER

The Family Reading Festival offers handson literacy activity stations, a Reader's Corner where local authors and community members read to children and Author's Alley where kids can meet Ohio authors. This grant helped fund the purchase of books and bags for the 2024 festival.



2023 GRANTS

EAST MUSKINGUM LOCAL SCHOOLS

East Muskingum Local Schools is bringing kindness to the forefront with a goal of empowering students to be academically successful as well as caring, empathetic individuals. This grant is supporting the district's Try Kindness program, fostering a culture of kindness, inclusivity and positive behavior among students, staff and the wider school community.

GUERNSEY COUNTY SENIOR CITIZENS CENTER

The Guernsey County Senior Citizens Center and Meals on Wheels Guernsey County, through the Meals on Wheels America-Premier Partnership with Abbott Laboratories, is collaborating with the local healthcare system and nonprofits to better serve individuals battling cancer. This grant is providing nutritional supplemental beverages to Guernsey County residents ages 60 and older who are diagnosed with cancer.

HOSPICE OF GUERNSEY INC.

Hospice of Guernsey's bereavement program has helped hundreds of individuals cope with grief, free of charge. Its annual widows' retreat brings women together for a weekend of activities, workshops guided by professional counselors and experience sharing. This grant is covering rental costs and supplies for the 2024 program.

NAZ CAFÉ

First Church of the Nazarene started its community outreach program, Naz Café, after finding many of the children picked up for Sunday morning services were coming to the church hungry. This grant is supporting those efforts, including a free weekly breakfast that serves individuals experiencing homelessness and the greater Guernsey County community.

ROLLING HILLS LOCAL SCHOOLS

Byesville Elementary School created a social-emotional wellness room that has been successful in decreasing discipline issues, assisting with the transition back to the classroom after episodes and educating students on coping skills. This grant is funding equipment for a new social-emotional wellness room for all students in grades 3-8.

RONALD MCDONALD HOUSE CHARITIES OF CENTRAL OHIO

Guernsey County families stay an average of 393 nights each year at the Ronald McDonald House – a home away from home while caring for their children who are battling serious illness at Columbus-area hospitals. This grant helps cover the cost of overnight stays, providing a safe haven for local families facing difficult times.

2023 GRANTS

SOCIETY OF ST. VINCENT DE PAUL CHRIST OUR LIGHT CONFERENCE

When a healthcare worker came to Society of St. Vincent De Paul Christ Our Light Conference for assistance with bills, the nonprofit saw an opportunity to help – while filling a community need. This grant is helping offset training and testing costs for residents to become certified State Tested Nurse Aides, helping our neighbors advance their careers and increasing the number of medical professionals.

VILLAGE OF BYESVILLE

Project Phoenix provides matching funds for commercial property renovations and business development in Byesville – positively impacting the community, culture and economic well-being of the village and its people. This grant is supporting Project Phoenix and its collaborative approach to promoting economic growth and opportunity in the community.



VILLAGE OF SENECAVILLE

This grant is helping to fund the initial phase of a project, spearheaded by the Village of Senecaville's Betterment Council, to create a safe place for families and community members to gather outdoors. The project will include the construction of a covered pavilion and purchase of picnic tables.

INVESTING IN GUERNSEY COUNTY'S YOUNG LEADERS

In 2023, FAO partnered with its affiliate foundations to support projects developed and implemented by local youth under age 18. The goal of this funding is to empower young leaders and inspire them to embrace greater roles in their communities. The Guernsey County Foundation awarded youth-led project grant funding to:

CAMBRIDGE HIGH SCHOOL

This grant will help cover travel costs for Cambridge High School students participating in the annual Ohio Model United Nations Conference, a three-day global education simulation that allows youth to learn about the operations and role of the United Nations. Forty-three Cambridge High School students are expected to participate in 2024.

THE IBELIEVE FOUNDATION

The grant is funding the participation of five Guernsey County high school students in the 2024 iBELIEVE Youth Leadership Workshops at no cost to them or their families. The workshops focus on leadership skill development with the goal of equipping young people to create positive change in their schools, communities and beyond.

HERE'S HOW IT WORKS

Through Nov. 8, 2024, or while resources last, FAO will match 50 cents on every \$1 given to endowed funds within GCF. That means:

\$100 GIFT BECOMES \$150 GIFT

\$10,000 **BECOMES GIFT**

\$15,000 **GIFT**

How much match funding is available to endowed funds within GCF's family of funds?	\$300,000
What's the maximum match?	\$100,000 per household
Can I make a pledge?	Yes! Pledges are eligible up to three years.
Are planned gifts eligible for the match?	New documented planned gifts of \$50,000 to endowments within GCF's family of funds are eligible for \$10,000 in match.
