2023 GRANTS

In partnership with the Foundation for Appalachian Ohio, the Harrison County Community Foundation awarded 11 grants, totaling \$31,890, in 2023.

CADIZ CUB SCOUT PACK 269

Cadiz Cub Scout Pack 269's annual day camp engages scouts in STEM activities – from building rockets to dissecting owl pellets. At this year's camp, scouts will learn about the life cycle of butterflies and even take home a caterpillar to raise into a butterfly, thanks to a grant that is funding materials and a new projector that the group will use year-round.

DEERSVILLE COMMUNITY PLAYERS

The Deersville Community Players serves as a center for artistic enrichment for individuals of all ages and a destination for local theater while maintaining the village's historic theater. Building on the impact of a 2022 grant that funded the replacement of the theater's stage flooring, this grant is enhancing areas used for costume, prop and scenery storage.

EASTERN OHIO EXTENSION CAMPS – 4-H CAMP PIEDMONT

For more than 70 years, 4-H Camp Piedmont has delivered local youth summer experiences and memories that last for lifetimes while also serving Harrison County families, businesses, nonprofits and visitors. This grant is funding new utility poles at the camp, increasing safety and enhancing the personal, social and environmental educational opportunities offered there.

HARRISON COUNTY DOG POUND VOLUNTEERS

The Harrison County Dog Pound Volunteers provide veterinarian services for homeless dogs that find themselves in the pound. This grant is supporting the nonprofit organization's work, with priority given to spaying and neutering – all in preparation for finding these furry Harrison County residents forever homes.

HARRISON COUNTY GENEALOGICAL SOCIETY

In 1938, Cadiz was designated the "Proudest Small Town in America" – a recognition of the many individuals of national prominence who hailed from the community and a testament to the contributions small towns make to American life. This grant is helping fund a new mural on Cadiz's Main Street that pays tribute to the 1938 recognition while beautifying the village and inspiring pride in the community.

HARRISON COUNTY TOURISM COUNCIL

Over the past three years, HCCF grants have contributed to a community effort to construct an outdoor performance stage and a backstage area at Sally Buffalo Park, culminating in the facility's opening in June 2023 and a successful inaugural summer concert series. The latest grant is sponsoring artists for the 2024 summer concert series, bringing the arts to the community and a boost to the local economy.

2023 GRANTS



A 2023 HCCF grant is supporting Lakeland Academy Community School's before-school programming, including free breakfast, and helping it to launch a new after-school program.

HUMANE SOCIETY OF HARRISON COUNTY

The Humane Society of Harrison County has been trapping and spaying or neutering feral and stray cats in Harrison County since 2020 – entirely through the efforts of volunteers who fundraise and apply for grants to cover costs. This grant is supporting their work and their mission to lower the overpopulation of cats in Harrison County.

THE iBELIEVE FOUNDATION

This grant is funding the participation of four Harrison County high school students in the 2024 iBELIEVE Youth Leadership Workshops at no cost to them or their families. The workshops focus on leadership skill development with the goal of equipping young people to create positive change in their schools, communities and beyond.

LAKELAND ACADEMY COMMUNITY SCHOOL

Lakeland Academy Community School offers students before- and after-school care, giving local children a source of nourishment and academic support outside traditional school hours. This grant is funding educational supplies and snacks for the program, which provides free breakfast and after-school help with reading, math and homework as well as internet access for students who do not have that essential learning tool at home.



A 2022 grant from HCCF allowed the Humane Society of Harrison County to spay or neuter at least 45 additional cats.

RONALD MCDONALD HOUSE CHARITIES OF CENTRAL OHIO

Harrison County families stay an average of 12 nights each year at the Ronald McDonald House – a home away from home while caring for their children who are battling serious illness at Columbus-area hospitals. This grant is helping to cover the cost of overnight stays, providing a safe haven for local families facing difficult times.

INVESTING IN HARRISON COUNTY'S YOUNG LEADERS

In 2023, FAO partnered with its affiliate foundations to support projects developed and implemented by local youth under age 18. The goal of this funding is to empower young leaders and inspire them to embrace greater roles in their communities.

HCCF awarded youth-led project grant funding to the Harrison Central Senior Group. The grant is funding a service-learning project spearheaded by four Harrison Central High School seniors who, in partnership with their peers in the school's shop class and community organizations, are creating a StoryWalk on the Conotton Creek Trail in Scio.

StoryWalks allow adults and children to read a book, section by section, while walking along a path, fostering a love of reading and for the outdoors and physical activity. The students spearheading this project aren't just giving back to their community; they're embarking on their legacies of service and making history as the StoryWalk will be the first in Harrison County.

Our Growing Home Fellow

In 2023, FAO and its affiliate foundations welcomed the inaugural class of Growing Home Fellows, including Harrison County resident Karli Ray, a children's librarian at Puskarich Public Library.

The Growing Home Fellowship is designed to recruit, retain and nurture our region's next generation of community builders. The inaugural class of 121 fellows, the "Classroom to Community Cohort," includes 18- to 35-year-olds who work with our

region's K-12 population. In exchange for committing to live, work and volunteer in their communities for five years, the fellows receive a financial stipend and access to a leadership program that includes service, skill development and peer learning.

Since becoming a Growing Home Fellow, Karli has volunteered to serve on HCCF's committee, adding to her record of service to her community.

Gifts to any endowment within the **Harrison County Community Foundation's family of funds** can have a larger impact, thanks to match dollars from the Foundation for Appalachian Ohio.

HERE'S HOW IT WORKS

Through Nov. 8, 2024, or while resources last, FAO will match 50 cents on every \$1 given to endowed funds within HCCF. That means:

\$100 GIFT BECOMES **\$150 GIFT**

\$10,000 GIFT BECOMES **\$15,000 GIFT**

How much match funding is available to endowed funds within AACF's family of funds?	\$300,000
What's the maximum match?	\$100,000 per household (There is no limit for gifts made to HCCF's main endowment while matching funds last.)
Can I make a pledge?	Yes! Pledges are eligible up to three years.
Are planned gifts eligible for the match?	New documented planned gifts of \$50,000 to endowments within HCCF's family of funds are eligible for \$10,000 in match.

This match is perfect if you wish to support our communities' greatest needs or most promising opportunities through the HCCF endowment OR if you wish to support or create another endowed fund under HCCF's family of funds.
